Sub: Course Registration and Commencement of Classes for Higher Semester Students of MBA Program for Odd Semester of the Academic Year 2024-25

This is to inform all Higher Semester Students of the MBA program that the Academic Session for the Year 2024-25 will commence from **September 18, 2024**. In this direction, please note the following.

1. The Attendance marking shall Commence from September 18, and Mandatory attendance of 75% shall be adhered to. Hence you must start attending classes from September 18, 2024 without fail.
2. The Fee for the Academic Year 2024-25 has been retained at the same structure, payable in two [2] equal Installments.
3. Students are required to remit their first Instalment of Fees on or before **September 20, 2024** to complete the Course Registration through LINWAYS Portal. Fee defaulters will not be allowed to attend the classes until the First Installment is paid in order to obtain Confirmed Registration.
4. Students with Fee-arrear, if any, of the previous Academic Year, will not be eligible to attend Classes, participate in any academic and non-academic activities of the University and to Register for the Odd Semester of the Academic Year 2024-25.
5. Additionally, we also have an arrangement with Financial Institutions for Interest-free Education Loan to Parents to enable the payment of the University Fee for the entire year, to be repaid, by the Parents, in Easy Monthly Installments. As a special benefit for the parents, Presidency University will bear the interest arising from this loan for the Academic Year 2024-25 only.
