CIRCULAR

Sub: Course Registration for Higher Semester Students of all Programs (Except MBA) who are ELIGIBLE for Odd Semester of the Academic Year 2023-24

Ref: Circular no: PU/2023/73 dated September 13, 2023 & Circular no: PU/2023/76 dated September 19, 2023

This is to inform all Higher Semester Students of the **School of Engineering, School of Commerce, School of Management (UG), School of Law, School of Design, School of Information Science, School of Computer Science and School of Media Studies** who are Promoted to the subsequent Semester as per Respective Academic Regulations, that such students must complete the Course Registration for Academic Year 2023-24 on or before **September 27, 2023**. In this direction, please note the following.

1. The Fee for the Academic Year 2023-24 has been retained at the same structure as of the Academic Year 2022-23, payable in two [2] equal Installments.
2. **Students are required to remit their First instalment of Fees to be eligible for Course Registration for Academic Year 2023-24. The last date for Course Registration is September 27, 2023 and no further extension will be given. Students who do not complete the Course Registration process will not be allowed to attend the classes or take part in any other academic activity.**
3. Students with Fee-arrear, if any, of the previous Academic Year, will not be eligible to attend Classes, participate in any academic and non-academic activities of the University and to Register for the Odd Semester of the Academic Year 2023-24.
4. Students who choose to pay the full fee (Both 1st and 2nd Installment of the Academic Year 2023-24) on or before September 30, 2023, will be offered a special one-time concession of Rs. 10,000/-, applicable only for Academic Year 2023-24, **subject to the condition that the 1st instalment is paid by September 27, 2023.**
5. Additionally, we also have an arrangement with Financial Institutions for Interest-free Education Loan to Parents to enable the payment of the University Fee for the entire year, to be repaid, by the Parents, in Easy Monthly Installments. As a special benefit for the parents, Presidency University will bear the interest arising from this loan for the Academic Year 2023-
