Sub: Registration and Commencement of On-Campus Classes of Winter/Even Semester for First Year B. Tech. Programs (Second Semester) and LL.M. (Second Semester) - Academic Year 2022-2023 Ref: Circular no: PU/2023/012 dated February 10,2023

Further to circular under reference on the subject cited, this is to draw attention of all the Winter/Even Semester Students of First Year B. Tech. Programs (Second Semester) and LL.M. (Second Semester), that they will have to report for On- Campus Classes for the Academic Year 2022-2023, commencing from February 27, 2023.

The Course Registration and the Regular Classes for Winter/Even Semester will commence on **February 27**, **2023**. All the Even Semester Students are hereby instructed to ensure that the Fee for the Even Semester is paid in Full, (including fee arrear for Odd Semester, if any) to be eligible for the Course Registration through MYCAMU Portal from **February 27**, **2023**. The last date to complete the Course Registration through MYCAMU will be **March 06**, **2023**. **Please note that the attendance marking shall Commence from February 27**, **2023 based on Provisional Registration**. **Hence, you must start attending classes from February 27**, **2023**, **regardless of your fee Payment status**.

Attendance will be calculated with effect from February 27, 2023 for all and the mandatory attendance of 75% shall be adhered to.

The last date of payment of fee is March 06, 2023. Fee Defaulters will not be allowed to attend the classes from March 07, 2023, until the full fee is paid in order to obtain **Confirmed Registration.** Hence, students are advised to pay the fee well in advance through MYCAMU Portal and complete the Course Registration procedure within the given time line.
