Sub: Course Registration and Commencement of Classes for MBA 3rd Semester Students for Odd Semester of the Academic Year 2023-24

This is to inform all Students of MBA 3rd Semester that the Academic Session for the Year 2023-24 will commence from September 11, 2023 onward. In this direction, please note the following.

1. The Attendance marking shall Commence from September 11,2023 and Mandatory attendance of 75% shall be adhered to. Hence, you must start attending classes from September 11,2023.
2. The Fee for the Academic Year 2023-24 has been retained at the same structure as of the Academic Year 2022-23, payable in two [2] equal Installments.
3. Students are required to remit their first Instalment of Fees on or before September 11,2023 to be eligible for Course Registration through MYCAMU Portal.
4. **Students who have remitted the fee for the Academic Year 2023-24 but are found to be not eligible for Promotion to the next higher Semester, post declaration of results, will not be allowed to register for the Courses. Fee Remitted, if any, will be refunded.**
5. **Students with Fee-arrear, if any, of the previous Academic Year, will not be eligible to attend Classes, participate in any academic and non-academic activities of the University and to Register for the Odd Semester of the Academic Year 2023-24.**
6. **Students who choose to pay the full fee (Both 1st and 2nd Installment of the Academic Year 2023-24) on or before September 30, 2023, will be offered a special one-time concession of Rs. 10,000/-, applicable only for Academic Year 2023-24.**
7. Additionally, we also have an arrangement with Financial Institutions for Interest-free Education Loan to Parents to enable the payment of the University Fee for the entire year, to be repaid, by the Parents, in Easy Monthly Installments. As a special benefit for the parents, Presidency University will bear the interest arising from this loan for the Academic Year 2023-24 only. **Any student opting for this facility will not be eligible for the special one-time concession of Rs. 10,000/- as specified in clause Six (6) above.**

The name of the Student, Class and his/her Roll Number should be mentioned on the reverse of the DD along with your Contact Number.
