## Circular

**Sub:** Commencement of Classes and Remittance of Total Fee for the Academic Year 2024-25 including fee arrears

**Ref:** Circular no. PU/2025/002 dated January 02, 2025, PU/2025/003 dated January 06, 2025, PU/2025/005 dated January 09, 2025, PU/2025/014 dated January 20, 2025 and Circular no. PU/2025/017 dated January 24, 2025

All eligible students are to hereby make note of the following important points that are applicable with the commencement of the Even Semester of the Academic Year 2024-25 on **January 20, 2025**.

1. Attendance-marking has commenced from **January 20, 2025**, and Mandatory Attendance of 75% shall be strictly complied with. Attendance calculation will be considered from January 20, 2025, irrespective of the date of joining.
2. Students are required to remit the balance fee and clear all fee arrears, if any, by **February 05, 2025 without penalty**. Thereafter, after the timeline of February 05, 2025, there will be a penalty of **Rs. 10,000/-** applicable from **February 06, 2025 to February 12, 2025** working hours.
3. The timeline has been extended based on the request made by students considering the fact that the new semester has just commenced. Hence, the earlier penalty of Rs. 5000/- levied on students who have paid full fee (as per the earlier timeline of January 24, 2025), shall be adjusted towards the next year fee. Refund shall be issued to students who are in the final year of their Academic program.
4. Students who fail to remit the Fee by **February 12, 2025** with the applicable penalty are to note that:
  - They shall not be Eligible for Registration in the Even Semester and are cautioned that they may lose an Academic Year.
  - Their names will be blocked from the Linways portal.
  - They shall not be permitted to attend Classes and/or participate in any Academic and Non-academic Activities of the University.
  - They shall not be given any further extension for fee remittance and Semester Registration.

**a. Digital Mode:** You can visit the designated website and remit the Fee indicated therein, against your name, through the link. <https://www.presidencyuniversity.linways.com>.

**b. Cash Remittance:** You may visit the designated Cash Counter at the University and pay the Fee.

**c. Demand Draft:** You may visit the designated Cash Counter at the University and deposit the Demand Draft. The Draft must be drawn in favor of Presidency University, payable at Bengaluru. The name of the Student, Program and his/her Roll Number should be mentioned on the reverse of the DD along with the Contact Number.
