In case the student wishes to furnish a written statement of the grievance, he/she may submit the same at the Office of the Member Secretary of Students Grievance Redressal Committee.

In case the student is not satisfied with the decision of the Redressal Committee, the aggrieved student may escalate the grievance to the Ombudsman at the following address, within 6 days of receipt of decision of the Committee.
