Sub: Course Registration and Commencement of Classes for Higher Semester Students for Odd Semester of the Academic Year 2025-26.

Dear Students,

This is to inform all the Eligible Students of Higher Semester's, that the Odd Semester of the Academic Year 2025-26 has commenced. In this direction, please note the following.

1. The Attendance-marking has commenced on **August 11, 2025**, and Mandatory Attendance of 75% shall be strictly complied with. Attendance calculation will be considered from **August 11, 2025**. Hence, you must start attending classes from the date notified herein above.
2. Students are required to remit their First Instalment of Fees (50% of the Total Fee) on or before **August 28, 2025 (without penalty)**, to complete the Course Registration through LINWAYS Portal, failing which:
 - i. You will not be Eligible for Registration in the Odd Semester and are cautioned that you may lose an Academic Year.
 - ii. You will not have access to the Linways portal.
 - iii. You shall not be permitted to attend Classes and/or participate in any Academic and Non-academic Activities of the University.
 - iv. You shall not be given any further extension for Fee remittance and Semester Registration
3. **Notwithstanding anything stated above, students will be permitted to remit their Fee Arrear between August 29 and September 10, 2025 (both days inclusive), subject to a one-time Penalty of Rs.5000/-, post which access of the student to the Linways portal will be blocked and he/she will lose an Academic year. Students may take it as last and final communication from the University on the subject matter.**
4. Should students have any queries regarding Course Registration and Commencement of Classes for Odd Semester, they may contact their respective Class Coordinators for required information.
