Sub: Commencement of Classes and Fee Remittance for Odd Semester of the Academic Year 2026-27 (Higher Semester UG programs and Higher Semester PG Programs)

This is to inform all eligible students that the Odd semester of the Academic Year 2026-27 has commenced from **August 05, 2026**. In this regard, please make note of the following instructions:

1. Attendance is calculated from August 05, 2026, and a minimum of **75% attendance** is mandatory as per University norms and shall be strictly enforced.
2. As per the circulars cited at reference, students were required to remit their First Instalment by August 10, 2026. However, an extension of time has been granted to students to pay their **First Instalment (50% of the total Fee)** of fee and clear the **fee arrears, if any**, on or before **August 22, 2026**.
3. Please note that, **no further extension will be granted**. Failing to remit the fee on or before the extended date of **August 22, 2026**, may lead to the following,
 - Students cannot attend Classes and/or participate in any Academic and Non-academic Activities of the University,
 - Students cannot claim attendance lost due to delay in fee payment.
 - **A penalty of Rs. 5,000/-** will be levied in the future.
4. Students are requested to make the remittance through **any one** of the following modes only:
 - Online payment through the Linways portal
 - POS machine swipe
 - Demand Draft (DD) drawn in favour of *Presidency University*, payable at *Bengaluru*.

Cash payments will not be accepted under any circumstances.
