Sub: Commencement of Classes and Fee Remittance for Odd Semester of the Academic Year 2026-27 (Higher Semester UG programs and Higher Semester PG Programs)

This is to inform all eligible students that the Odd semester of the Academic Year 2026-27 has commenced from **August 05, 2026**. In this regard, please make note of the following instructions:

1. Attendance is calculated from August 05, 2026, and a minimum of **75% attendance** is mandatory as per University norms and shall be strictly enforced.
2. As per the circulars cited at reference, students were required to remit their First Instalment by **August 22, 2026**. However, an extension of time has been granted to students to pay their First Instalment (50% of the total Fee) and clear the **fee arrears, if any**, on or before **August 26, 2026**. Students are advised to **strictly adhere to the extended deadline, as no further extension will be granted**.
3. Failure to remit the required fee **on or before August 26, 2026**, will result in a penalty of **Rs.5,000/-** being levied from **August 27, 2026** and;
 - Students cannot attend Classes and/or participate in any Academic and Non-academic Activities of the University,
 - Students cannot claim attendance lost due to delay in fee payment.
4. Students are requested to make the remittance through **any one** of the following modes only:
 - Online payment through the Linways portal
 - POS machine swipe
 - Demand Draft (DD) drawn in favour of *Presidency University*, payable at *Bengaluru*.

Cash payments will not be accepted under any circumstances.
