The comprehensive programme equips students with the knowledge, skills, and industry exposure needed to excel in the dynamic world of commerce.

Career Options

B.Com. graduates have numerous career opportunities in finance, accounting, and business analytics. They can explore roles in banking and credit analysis (**Credit Analyst, Loan Officer**), financial management (**Financial Analyst, Cost Accountant**), and taxation and auditing (**Tax Associate/Consultant, Internal Auditor, External Auditor, Audit Associate**). Additionally, they can pursue careers in market research and business strategy (**Market Research Analyst**) or specialise in corporate finance and risk assessment.

Candidates seeking admission to B.Com. must have passed 10+2 or an equivalent examination from any recognised board with a minimum of 50% marks in aggregate.

Programmes Offered

B.Com. – Banking & Finance

This programme develops knowledge, skills, and attitude required to pursue a career in banking & finance. Students are exposed to the conceptual nuances of financial accounting, cost accounting, banking law & operations, financial markets, financial management, security analysis, derivative markets, and risk management. The programme is integrated with an internship programme that will help to hone their 'on the job' skills expected of banking & finance professionals. In addition, the students are given an option to receive specialised coaching to prepare them for the CA–Foundation Examination if they opt for the same.

B.Com. – Accounting & Taxation

This programme imparts in-depth knowledge and skills in understanding concepts associated with corporate accounting and taxation. The curriculum offered includes a blend of contemporary areas of domain expertise, like accountancy, management, analytics, auditing, banking, taxation, derivatives, risk management, and law. Primarily oriented at producing commerce graduates equipped to meet the challenges of the contemporary business world, it helps train students to pursue higher education in the realm of professional accountancy, like chartered accountancy, company secretaryship, and cost management accountancy. In addition, the students are given an option to receive specialised coaching to prepare them for the CA–Foundation Examination if they opt for the same.

B.Com. – Corporate Accounting Integrated with CMA –US

This programme equips students with expertise in Professional and Corporate Accounting, integrated with the Certified Management Accountant (CMA-US) curriculum. It covers key financial concepts such as financial statement analysis, cash flow interpretation, and corporate restructuring, with a strong focus on ethics and statutory compliance. Students gain global recognition through IMA (US) membership and can appear for the CMA exam in their fourth semester.



B.Com. – Business Analytics

This programme equips students with data interpretation skills using statistical tools like "R" to support data-driven decision-making. With businesses relying on analytics for success, the curriculum covers Applied Business Analytics, Data Science with R, Predictive Analysis, and domain-specific analytics in marketing, finance, and HR. Students also have the option for specialised coaching for the CA Foundation exam.

B.Com. – CA Foundation

This programme integrates core B.Com. subjects with the CA Foundation syllabus, providing a strong foundation in commerce, accounting, and finance while preparing students for a Chartered Accountancy (CA) career.

B.Com. (ACCA)

This programme integrates B.Com. syllabus with ACCA (Association of Chartered Certified Accountants), which leads to the award of Bachelor's Degree in Commerce [B. Com] and also offers exemptions from 9 courses of the ACCA program. ACCA is a globally recognized certification for professional accountants, acknowledged in 180 countries, and opens diverse career opportunities in both accounting and finance domains.
