Day Two – Simulation Competition: A hands-on boardroom crisis simulation where participants step into the roles of directors, lawyers, regulators, and stakeholders to resolve high-stakes corporate dilemmas.

DAY 01 - ACADEMIC EXCHANGE **ENGAGE. LEARN. EXCHANGE**

The sessions blend conceptual clarity with practical insights on governance crises, stakeholder dynamics, and digital innovation in boardroom practices. Through keynotes, panels, and interactive dialogues, participants engage with contemporary challenges in governance and regulation, fostering reflection, networking, and readiness for the Day 02 simulation.

DAY 02 - SIMULATION COMPETITION **STEP INTO THE BOARDROOM**

Is structured as an academic simulation that mirrors the internal governance mechanisms and legal advisory processes of corporate entities. It invites students to assume the roles of corporate management and legal advisors in navigating multifaceted, real-world inspired scenarios involving fiduciary responsibilities, regulatory compliance, shareholder interests, and ethical challenges. Through this format, the event endeavours to foster a deeper, practice-oriented understanding of corporate law and governance in the context of modern enterprise regulation.

Participants will engage with a challenging corporate situation involving competing commercial, legal, and ethical considerations. Each participant must defend the interests associated with their role, contribute to the evolving discussion, and work collaboratively (or in opposition) to reach a consensus or document dissent.

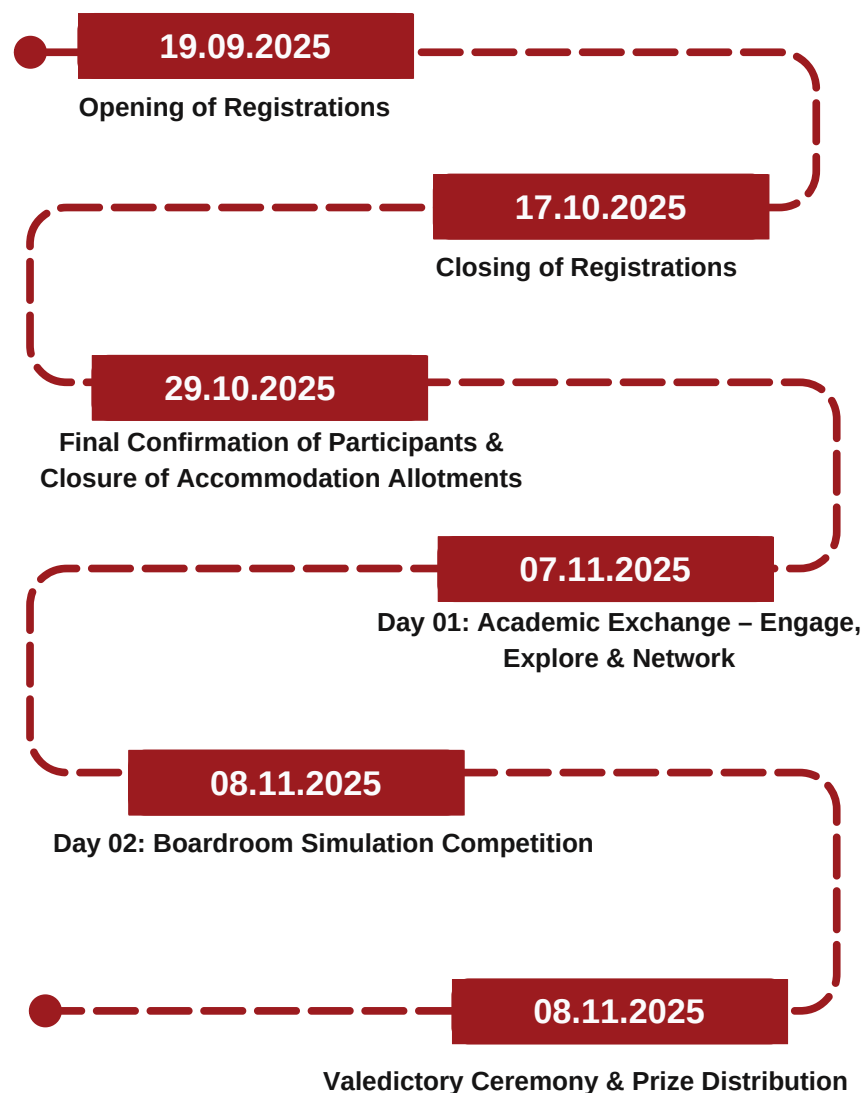
TEAM FORMATION

Participation takes place in two modes:

- **Team Participation:** Each institution may nominate teams consisting of five (5) members, with each member being assigned a distinct role (Chairperson, Company Secretary, Independent Director, External Legal Counsel, Small Shareholder Director).
- **Individual Participation:** Students may also register individually. Such participants will be grouped into composite teams by the Organising Committee and will be informed of their final team composition at least seven (7) days before the commencement of the Workshop.

The allocation of roles ensures representation of strategic, legal, financial, and shareholder perspectives, thereby mirroring real-world governance challenges.
