Introduction

Presidency School of Law, approved by the Bar Council of India and Govt. of Karnataka, offers **two distinct five-year integrated bachelor's honours programmes: B.A., LL.B. [Hons.], and BBA LL.B. [Hons.]** to equip legal professionals with the necessary skills for diverse contexts. The integrated honours law curriculum includes courses focused on personal and professional skill development, such as Professional Communication, Researching and Reasoning Skills, Advocacy Skills, and Drafting Skills. These skills are further refined through moot courts, legal aid clinics, and internships, which prepare them for real-world legal challenges.


Additionally, students can personalize their legal education by choosing from a range of electives, along with two undergraduate programme-specific major courses, allowing them to tailor their studies to their career goals.

The school also offers a one-year master degree programme for exploring expertise and enhancing knowledge in various areas of law.

Career Options

Graduates with a five-year integrated LL.B. or LL.M. have diverse career opportunities in the legal and corporate sectors. They can pursue roles in litigation and advocacy (**Lawyer, Legal Consultant, Public Prosecutor**), corporate law (**Corporate Lawyer, Compliance Officer, Mergers & Acquisitions Specialist, Legal Process Outsourcing**), and intellectual property law (**Patent Attorney, Trademark Consultant, IPR Expert**). Those interested in criminal and civil law can work as **Criminal Lawyers, Civil Litigators**, or **Human Rights Advocates** and as a **legal advisor** for NGOs. Other options include judicial services (**Judge, Legal Advisor in government and legal bodies, Court Officer**) and alternate dispute resolution (**Arbitrator, Mediator**). After completing LL.M., students can pursue academic roles higher education as **law professors** or **legal researchers**.





Eligibility

Five Year Integrated Law Honours Programme (B.A. LL.B. / BBA LL.B.)

A candidate seeking admission to the BBA LL.B. (Hons.) and B.A. LL.B. (Hons.) programmes must have passed 10+2 or an equivalent examination from any recognised board with a minimum of 45% marks in aggregate. If the prescribed authority mandates an age limit for admission, it will be strictly adhered to. Candidates exceeding 20 years of age as of July 1 in the admission year must submit an undertaking to the university accordingly.

Master of Laws (LL.M.)

Candidates seeking admission to the one-year Master of Law (LL.M.) degree programme must have passed a 3-year LL.B. degree or a 5-year integrated law degree from a recognised university, with at least a minimum of 50% in aggregate of the total marks of the qualifying examination, and 45% aggregate marks in the case of candidates belonging to SC/ST and other reserved categories. Admission to the LL.M. programme is based on merit, All India Admission Test scores, and an interview by Presidency University (CPGLS), assessing aptitude for teaching, research, legal reasoning, and comprehension.

BBA LL.B. (Hons.)


