MoU Signing Ceremony between Presidency University and Chronic Foundation

1. About Event

The Institutional Social Responsibility (ISR) Cell, Presidency University, successfully organized the MoU Signing Ceremony between Presidency University and Chronic Foundation on 2 September 2026 at Presidency University.

*The Memorandum of Understanding (MoU) marked the commencement of a collaborative partnership between **Presidency University and Chronic Foundation**, with the objective of working together on **skill development, women empowerment, livelihood creation, CSR initiatives, and other community development activities.***

*The partnership establishes a framework for collaboration on **skill development and employability programmes, women empowerment and livelihood initiatives, CSR-supported social development programmes, the Women E-Auto Initiative proposed by the University, and other mutually agreed community and social-impact initiatives.***

The MoU signing ceremony brought together representatives from Presidency University and Chronic Foundation to formally establish the partnership and discuss opportunities for implementing impactful initiatives. The collaboration aims to create meaningful opportunities for students, youth, women, and other identified beneficiaries through skill development, entrepreneurship, livelihood enhancement, and community-oriented programmes.

The MoU was established with the following objectives:

- To establish a formal framework for collaboration between Presidency University and Chronic Foundation.
- To implement **skill development and employability programmes** for students, youth, women, and other identified beneficiaries.
- To promote vocational, digital, employability, soft skills, entrepreneurship development, career guidance, and industry-oriented training.
- To support **women empowerment and sustainable livelihood opportunities** through the proposed Women E-Auto Initiative.
- To facilitate CSR-supported initiatives in areas including skill development, women empowerment, livelihood development, education, digital literacy, community development, environmental sustainability, rural development, and youth development.
- To create opportunities for collaborative community and social-impact initiatives that are mutually beneficial to both organizations.

4. Event Proceedings

The ceremony commenced with a warm welcome to the dignitaries and representatives from Presidency University and Chronic Foundation. The gathering highlighted the significance of institutional partnerships in addressing community needs and creating sustainable social-impact opportunities.

The dignitaries were formally introduced, followed by an overview of the purpose and objectives of the collaboration. The partnership was presented as a framework for joint efforts in **skill development, employability, women empowerment, livelihood creation, CSR initiatives, and community development**.

The **Memorandum of Understanding** was formally signed by **Dr. Venkateswaran S, Registrar, Presidency University, and Mr. Ramesh Shivanna, Chairman, Chronic Foundation**, marking the official commencement of the collaboration. The MoU identifies both organizations' responsibilities in planning, implementing, supporting, and monitoring mutually agreed initiatives.

Following the signing, the representatives discussed potential areas for implementation under the MoU. The discussions included opportunities for **vocational and job-oriented skills, digital skills, employability and soft skills, entrepreneurship development, career guidance, industry-oriented training, certification and placement support**, wherever applicable.

The representatives also discussed the proposed **Women E-Auto Initiative**, which aims to support eligible women through skill and driving-related training, entrepreneurship and financial literacy, potential e-auto sponsorship or CSR funding, facilitation of government schemes wherever applicable, and sustainable livelihood opportunities.

The ceremony concluded with a vote of thanks and a commemorative group photograph, marking the beginning of the collaborative partnership between Presidency University and Chronic Foundation.

5. Outcomes & Impact

The MoU Signing Ceremony successfully formalized a collaborative framework between Presidency University and Chronic Foundation for implementing social-impact initiatives.

Key outcomes included:

- Creation of a framework for **skill development and employability programmes** for students, youth, women, and other identified beneficiaries.

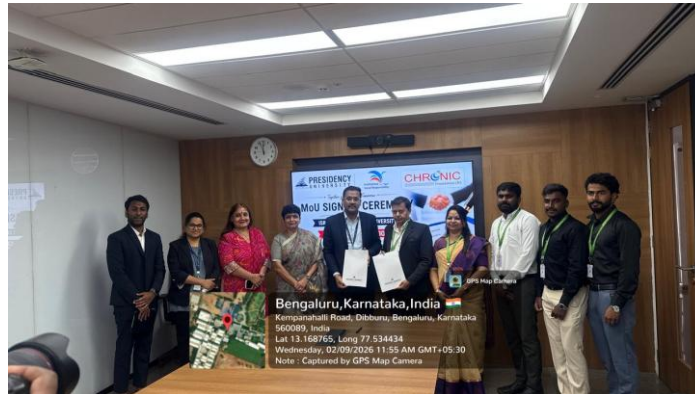
