EVENT REPORT

Provision of Bus Transport Facility to Government School Students

1. About Event

The Institutional Social Responsibility (ISR) Cell, Presidency University, undertook an initiative to support students of a Government Higher Primary School in Challahalli by providing a dedicated bus transport facility to enable safer and more convenient access to school.

The initiative was undertaken with the objective of addressing transportation-related challenges faced by students from the surrounding villages and supporting their regular access to education. The school is located approximately 9 km from Presidency University, and around 61 students benefit from the transport facility.

The provision of bus transportation represents a community-focused initiative aimed at creating a safer and more accessible commuting arrangement for school-going children. By facilitating transportation to and from the school, the initiative seeks to reduce barriers associated with distance and accessibility while supporting students in continuing their education in a secure and convenient manner.

The initiative reflects Presidency University's commitment to Institutional Social Responsibility, community engagement, and supporting access to education through practical interventions that address identified community needs.

3. Objectives

The initiative was undertaken with the following objectives:

- To provide safe and accessible transportation for school-going students.
- To support students from surrounding villages in accessing their school conveniently.
- To reduce transportation-related challenges arising from distance and limited commuting options.
- To facilitate a more reliable and secure daily commute for students.
- To support regular access to education by addressing practical transportation barriers.
- To contribute towards the overall well-being and safety of school-going children.
- To strengthen community engagement and support initiatives undertaken as part of Institutional Social Responsibility.

4. Event Proceedings

The initiative commenced with a visit by representatives of the Institutional Social Responsibility (ISR) Cell, Presidency University, to the Government Higher Primary School in Challahalli.

During the visit, the need for accessible and safe transportation for students from the surrounding villages was highlighted. The school, located approximately 9 km from Presidency University, serves students for whom daily transportation can present a practical challenge.

As part of the initiative, Presidency University facilitated a bus transport facility for the students, providing them with a safer and more convenient mode of transportation for their daily commute to and from school.

The initiative was undertaken with the aim of ensuring that distance and transportation-related difficulties do not become barriers to students' regular access to education. Approximately 34 students are expected to benefit from the facility.

The representatives also interacted with the school community and highlighted the importance of ensuring safe and dependable transportation for school-going children. The initiative demonstrated the University's efforts to respond to community needs through practical and sustainable support measures.

The programme concluded with interactions with the students and school representatives, marking an important step towards strengthening the University's engagement with the local community.

5. Outcomes & Impact

The bus transport initiative is expected to create a positive impact on the students and the wider school community.

Key outcomes included:

- Provision of a safer and more convenient transportation facility for approximately 34 students.
- Improved accessibility to the Government Higher Primary School for students from surrounding villages.
- Reduction of transportation-related difficulties associated with distance and daily commuting.
- Support for students in maintaining regular access to their educational institution.
- Creation of a more secure and dependable commuting environment for school-going children.

The provision of a bus transport facility to students of the Government Higher Primary School, Challahalli, marks a meaningful initiative under the Institutional Social Responsibility (ISR) Cell, Presidency University.

By facilitating safe and accessible transportation for approximately 34 students, the initiative seeks **to address transportation-related barriers and support students in accessing their school regularly and conveniently.**

Through such need-based interventions, Presidency University continues to contribute towards creating meaningful and sustainable positive outcomes for the communities it serves.
