Village Reconnaissance – Identifying Community Needs for Rural Development

1. About Event

*The **Institutional Social Responsibility (ISR) Cell, Presidency University, Bengaluru**, conducted a **Village Reconnaissance Visit** to understand the existing conditions, challenges, and developmental requirements of communities in the villages under **Sonnenahalli Gram Panchayat**.*

*The reconnaissance involved **SOLAS students**, who visited the villages and documented observations related to basic infrastructure, education, health, livelihoods, sanitation, environment, and community needs. The activity was intended to provide a ground-level understanding of the villages and help identify areas where future ISR interventions can be planned.*

2. Event Details

3. Objectives

The reconnaissance was organized with the following objectives:

- To understand the existing conditions and community needs in the villages.
- To identify requirements related to **water, roads, drainage, street lighting and public spaces**.
- To assess areas related to **education, health, women and children, and livelihoods**.
- To observe environmental and waste-management concerns.
- To encourage students to engage with community-oriented and rural-development initiatives.

4. Event Proceedings

The student teams visited **Challahalli, Haniyur and Sonnenahalli** as part of the reconnaissance activity. The visits were conducted through separate trips using a university bus, allowing the students to spend adequate time observing each village.

Students documented their observations through **photographs, videos, notes and field-level discussions**. Particular attention was given to basic infrastructure, sanitation, education, healthcare, livelihood opportunities, environmental conditions and other requirements identified within the communities.

The information collected during the reconnaissance will serve as a preliminary reference for understanding the villages and identifying potential areas for future community-development initiatives by the ISR Cell.

5. Outcomes & Impact

- Provided students with **first-hand exposure to rural community conditions**.
- Helped identify key developmental and infrastructure requirements.
- Created a preliminary record of community needs through field observations.
- Encouraged student participation in socially responsible activities.
- Generated inputs for planning future ISR interventions.
- Strengthened the University's engagement with surrounding rural communities.
