- **Last date for Registration & Payment of Fees:** **12<sup>th</sup> July 2019**
- Students applying for Make-Up Examinations, July 2019 should submit the Registration Form along with the photocopies of their Grade Card/s to the Controller of Examinations office for verification.
- After verification, student should Pay the Examination Fees of Rs. 1,000/- per Course to the **Cash Section** of the University and **submit the form** along-with fees paid receipt to the Controller of Examinations office.
- Applications submitted on plain paper or late registrations will not be accepted.
- **Students who are having NE / NP grade in any course/s cannot register for Make-Up Examinations, July 2019 of that particular course**
