The School of Law offers both, Undergraduate Integrated 5-year Bachelor's Degree Programme in Law as well as a 1-year Master's Degree Programme in Law. The Integrated 5-year Bachelor Degree Programme in Law has transformed the quality of legal education. It was conceived with an objective to bring legal education as a complete professional course and provides the opportunity for a fresh 10+2 pass-out Students to make an immediate career choice.

The interdependence between social sciences and law hardly needs to be articulated. With the rapid growth of the Indian economy and global business footprint, integration of management sciences, economics and commerce with legal education becomes a necessity to ensure qualified and skilled graduates to cater to diverse opportunities in the legal profession.

The School of Law has specifically designed three different 5-Year Integrated Bachelor Degree Honors Programmes, viz., B.A LL.B.[Hons.], BBA LL.B. [Hons.], and B.Com LL.B. [Hons.], to prepare legal professionals for the diverse contexts.

The Post-Graduate Programme in Law is offered in two distinct domain areas - Intellectual Property Rights and Technology Law.

Legal Pedagogy at Presidency University

The pedagogy adopted for such Integrated Programmes emphasizes multi-disciplinary research and inquiry, participative learning, blended learning using online resources, case studies and discussion seminars in addition to the classroom lectures. A very critical aspect of the learning process is to develop the skills and attitudes imperative for competence as a legal professional. With this objective the Integrated Honors Law Curriculum has courses on personal and professional skill development like Professional Communication (including courses in General and Legal English), Researching and Reasoning Skills, Advocacy Skills and Drafting Skills. All such skills are refined through Moot Courts, Legal Aid Clinics and Internships that are conducted in compliance with the requirements of the Bar Council of India.

Eligibility - 5-Year Integrated Law Program:-

[B.A LL.B.[Hons.], BBA LL.B. [Hons.], & B.Com LL.B. [Hons.]

The candidate seeking admission to the B.B.A.LLB (Hons.), B.Com.LLB, B.A.LLB. (Hons.) Programs should have passed 10+2 or an equivalent examination from any recognized board with a minimum of 40% marks in aggregate. Should an age limit to such admission, be mandated by the prescribed authority, the same will be binding on all such admissions. Candidates, whose age is above 20 years as on July 01 on the year of admission, shall furnish an undertaking to the university to this effect.

LL.M.

Candidates seeking admission to One-Year Master of Law (LL.M) Degree Program should have passed 3 year LLB Degree or 5 year integrated Degree from an recognized university, with at least minimum 50% in Aggregate of the Total Marks of the Qualifying Examination. 45% aggregate marks in case of candidates belonging to SC / ST and other Reserved Categories.

The admission to One Year Master of Law (LL.M) Program shall be based on merit in the qualifying degree, scores secured in the All India Admission Test conducted every year by the Universities individually or by a Group of Universities collectively, specifically for this purpose, with the objective of testing aptitude for teaching/research, legal reasoning, and comprehension / basic legal knowledge and interview conducted by Presidency University, Centre for Post-Graduate Legal Studies (CPGLS).

B.A. LL.B. [Hons.]

This Five-Year Integrated Program provides a strong foundation and insight into the political factors that influence policies to transform themselves into law and highlights the intricate relationship between legislations and social problems. It integrates courses in Political Science, Sociology and Economics with the courses in Law for students who prefer to build their careers as Legal Professionals. It equips students with the knowledge, skills and attitude required to seek careers in International Trade and Commerce, Intellectual Property Rights, Global Mobility and International Laws.
