At the behest of the Chairperson, the Deputy Director, IQAC informed the members of the need to implement Value-added courses imparting transferable and like skills as required by most of the Accrediting Bodies. Deputy Director, IQAC, requested all the Deans of respective schools, Heads of respective Departments to plan for Value- added courses Programs with 30-contact hours. The various MOOC options were also placed before the Members.

At the behest of the Chairperson, the Deputy Director, IQAC, presented to the members the Draft Format of the Structured Feedback, from different stake holders like 1) Students

Agenda 4.7: To Identify Advanced Learners and Slow Learners and to introduce the Policy for the same.

The Chairperson called upon the Deputy Director, IQAC to place before the Members the Note highlighting the need to introduce norms for identifying the Advanced Learners and Slow Learners and to present the Draft Policy guidelines associated with the same. The Dean-Academics suggested that after Test1 [T1] it is very important to identify slow learners and run remedial classes for such slow learners. The Policy for identifying Advanced and Slow Learners was placed before the Members.

The Members discussed the same and resolved as under

"Resolved that the Draft Policy guidelines for Identifying Advanced and Slow Learners towards ensuring Advanced learning options for Advanced Learners and Remedial Classes for Slow Learners as was placed before the members, as Annexure VI be and is hereby approved with a direction that the same be placed before the prescribed Bodies for due ratification"

Carried Unanimously

Agenda 4.8: Review on publications for the last academic year 2018-19.

Deputy Director, IQAC, presented to the members the overall publications of the University for the academic year 2018-19. The overall publications in Journals was 123 and publications in Conferences was 94. However the members were of the opinion though the number was encouraging, the number of sponsored research projects by external funding agency is less than University's expectation and the Dean, R & IC, to organize workshop so that Faculty Members are more acquainted on writing proposals for external funding agencies

Post discussion the Members resolved that there is a need to enhance research and innovative activities and that in that direction Dean-Research to drive the need for larger number of publications and participation at Conferences.

Agenda 4.9: Capability enhancement and development schemes.

Deputy Director, IQAC, requested the Dean's and HOD's of the respective department to plan for Students Capability Enhancement and Development Schemes. In this regard, Dr. Udaya Ravi M, Professor & HOD of Mechanical Department, spelt out the plans chalked out by Mechanical Department in providing GATE coaching for interested students on Saturdays and Sundays. The Members appreciated the efforts.

The Members discussed and decided as under

"Resolved that the University be and is hereby authorised to introduce Capability Enhancement and Developed Programs at School-Level and/or Department-level for the overall and holistic development of students keeping in line with the best practices adopted by the University from time to time"

Carried Unanimously

Agenda 4.10: Implementation of computer based examination [Paper less examination].

Dean Academics informed the members the proposal of implementation of computer based examination [Paper less examination] for all the first year admitted students for the academic year 2019 and to administer the test in the "EDHITCH" environment. The advantages, disadvantages and the challenges of the computer based examination was deliberated in detail. However, since the approach was unique, it was decided if feasible to have test -1 in form computer based examination and detailed schedule to be prepared by Dean Academics.

The Members deliberated upon the same to understand as to whether the University is indeed ready to migrate into the digital examination mode. The Dean Academics satisfactorily responded to the various queries of the Members. Post discussion it was decided as under.

"Resolved that the University be and is authorized to migrate into the realm of digital examinations as from such time as the University Leadership considers it feasibly, taking into consideration the availability of the Information Technology related infrastructure and the preparedness of the University in so conducting digital examinations and that the Dean-Academics be and is hereby authorized to conduct an evaluation and submit a plan for such migration "

Carried Unanimously

Agenda 4.11: Implementation of Active Learning.

Dean Academics informed the members the proposal of implementation of Student centric methods [Active Learning] to provide flexible learning environment to the Students which includes Experiential Learning, Participative Learning, Technology Enabled Learning, Open Book Test, Flipped Class Technique, Problem Based Learning etc. Members appreciated the efforts of implementing this unique technique and noted the same.

The Members discussed and decided as under

"Resolved that the University be and is hereby authorised to introduce Active Learning and that the Dean-Academics is hereby authorized to submit a plan for such activity"
