

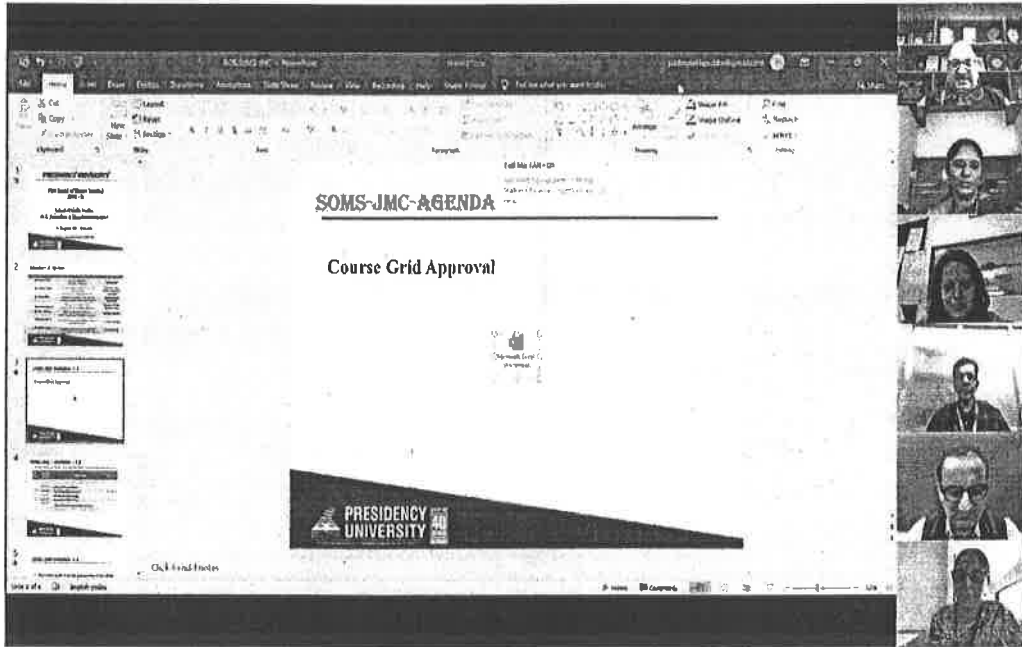


Fig. 1. The screenshot picture of 1st BoS meeting on MS Teams


