#### **AGENDA 6.2:**

#### Approval of Program Structure and Curriculum for the 2018-20 Batch of MBA Program.

**Comment:** The MBA Program Structure and Curriculum from the 1<sup>st</sup> Semester to 4<sup>th</sup> Semester for 2018-20 was discussed and deliberated in detail. The following changes were recommended:

- 1. The course titled 'Foundation Mathematics' in Semester I to be renamed as 'Mathematics for Managers'.
- 2. The course titled 'Financial Risk Analytics' (Data Science Specialization Elective) be renamed as 'Financial Analytics'.
- 3. The content coverage of the course 'Business Laws' pertaining to Semester II (2 Credits), be limited to elements of Commercial Law, Negotiable Instruments Act, Company Law, overview of Consumer Protection Law and Labour Laws only.

**Resolution**: The members have approved the Program Structure and Curriculum for 2018-2020 with the above mentioned changes/recommendations.

#### To ratify the MBA Program Regulations of MBA 2018-20 Batch

**Comment:** The members reviewed the suggested MBA program regulations and accepted the proposed regulations.

Comment: A student by name Ms Dorini J Kisaka with Registration Number 2016MBA901, originally pertaining to 2015-17 batch, after having completed the I and II semester took a sabbatical and reregistered for the III Semester along with 2016-18 batch. On her successful completion of IV semester, the total credits earned by her would be 103 credits as against the minimum qualifying credits requirement of 104 credits for 2016-18 batch. The Chairman welcomed the members present for the meeting. Leave of absence was requested for and granted to members Dr Swapan Majumdar and Mr Sudhir Banerjee who could not be present in the meeting. The Chairman briefed the members on the objectives of the meeting and need for the proposed revisions for the MBA Program Structure and Curriculum to be offered at Presidency University for the 2019-21Batch.

#### Agenda – 8.1

To approve the minutes of 7<sup>th</sup> Board of Studies Meeting held on 2<sup>nd</sup> January, 2019.

**Comment:** Board noted and approved the minutes of the 7<sup>th</sup> Board of Studies meeting.

**Resolution:** Resolved that the minutes of the 7<sup>th</sup> Bard of Studies Meeting held on 2<sup>nd</sup> January 2019, as placed before the members and herewith appended as Annexure I, be and is hereby approved.

#### Agenda – 8.2

To consider and approve the Program Regulations for MBA 2019 -21 Batch.

**Comment:** The revised MBA Program Regulations from the I Semester to IV Semester of 2019-21 batch was discussed and deliberated in detail. The following changes were recommended:

1. Metrics for assessing the different project options was discussed.





- 2. The board appreciated the various project options provided and suggested to identify Mentors from corporate houses for guiding the students. It was suggested that in case of entrepreneurial projects/research projects, the students may choose to continue the project work till the fourth semester.
- 3. It was suggested to identify NGOs and consulting firms related to NGO which provides opportunities in social consulting. The organisation should focus on developing managerial skills apart from sensitisation on social issues.
- 4. The board suggested that the industry feedback for projects can be collected through online/one on one interaction with the industry guide without the knowledge of the student. Industry feedback in the written form may not be made mandatory and can be supplemented with feedback resulting from faculty interaction with Industry mentor.
- 5. The board approved the list of MOOC Courses with some minor changes. They also suggested to identify courses which are not offered by University.
- 6. The board authorized the Chairperson to restructure the Regulations related to Summer Projects/Dissertation and MOOC Courses and implement the same.

**Resolution**: Resolved that the above revisions in the Program Regulations from the I Semester to IV Semester of the 2019-2021 batch herewith appended as Annexure II, be and are hereby approved.

Agenda – 8.3

To consider and approve Program Structure and curriculum for MBA 2019 -21 Batch:

- a) MBA Dual Specialization
- b) MBA Digital Marketing
- c) MBA E Commerce

#### **Comment:**

- 1. It was suggested that the fundamentals of data analysis in the Course 'Data analysis using Spreadsheets' shall be offered as a MOOC course. It was suggested that the MOOC course should be supplemented with blended learning and guest lectures. It was also suggested that students may be provided with real time data sets (obtained from industry) to solve real time business problems.
- 2. The board also suggested that the concepts learnt in Business statistics course should be practiced in the Course 'Data analysis for Spreadsheets'.
- 3. It was suggested to include the concept of Johari Window in Organizational Behaviour Course offered in I Semester.
- 4. It was suggested to include some components of the 'Story telling with Data' in Personality and Professional Skill Development courses.
- 5. The board suggested to detail and list the pre-requisites for all the courses that are offered in the higher semester.
- 6. The specialization core and elective courses offered in MBA (Dual Specialization) was discussed in detail. The suggestions are as follows:
  - a. 'Marketing Analytics' may be added as a Marketing Elective in place of 'Business Marketing'. It was also suggested to cover the concepts related to b2b marketing in 'Marketing Management-II' offered in II Semester.
  - b. 'Financial Analytics' may be added as a Finance Elective in place of 'Project Finance and Appraisal'. It was also suggested to cover the concepts related to project financing and appraisal in 'Strategic Financial Management' offered in III Semester.





- c. 'Talent Acquisition and Management' may be renamed as 'Talent Management'. It was suggested to cover the entire employee life-cycle aspects in the course.
- d. It was suggested that the courses 'Logistics and Supply Chain Management' and 'Global Logistics and Supply Chain Management' listed under operations and supply chain specialization shall be combined and renamed as 'Global Integrated Supply Chain'.
- e. 'Business Forecasting with R' may be renamed as 'Business Forecasting'.
- f. The Board suggested to introduce a MOOC course which covers the fundamentals of Big Data, Artificial Intelligence and Machine Learning.
- g. The courses 'Predictive Analytics', 'Train the Trainers' and 'Creating Happy and Meaning Careers' offered as a MOOC course shall be dropped. Some other relevant courses can be identified and added.
- 7. The courses offered in MBA (E-Commerce) was discussed in detail. The suggestions are as follows:
  - a. It was suggested to include the concepts of 'pricing analytics' in the course 'Cost & Revenue Management' offered in III semester.
- 8. The specialization core and elective courses offered in MBA (Digital Marketing) was discussed in detail. The suggestions are as follows:
  - a. 'Web Development' may be renamed as 'UI Development'. It was suggested to include the various aspects of web development and mobile app development in the course.

**Resolution**: Resolved that the suggested changes shall be incorporated in the Program Structure and curriculum for MBA 2019-21 batch and the Chairperson is hereby authorized to approve the same. It is also resolved that Course Description and Syllabus for 2019-21 Batch be drafted and the Chairperson is hereby authorized to approve the same.

#### Agenda – 8.4

To consider and approve the changes to MBA 2018 – 20 Batch Program Regulations.

**Comment:** The changes pertaining to MBA 2018–20 Batch Program Regulations was discussed in detail. The changes are as follows:

- a. Introduction of MOOC courses and transfer of credits shall be applicable to MBA 2018-20 batch.
- b. The 'Industrial Practice / Dissertation' in the IV Semester of MBA Program 2018-20 batch be renamed as 'Dissertation', be assigned grades and included in the computation of CGPA. The projects options available for MBA 2019-21 is also applicable to this batch
- c. The HR specialization elective course 'Human Resource Metrics and Analytics' may be renamed as 'HR Analytics' for the MBA 2018-20 batch.

**Resolution:** Resolved that the changes shall be incorporated and the chairperson is authorized to approve the changes.
