- (1) POST: Professor, School of Engineering in Presidency University.
- (2) DATE OF JOINING: You will be required to report and join employment on 1st February ,2016
- (3) TERMS OF APPOINTMENT:
- (a) You will be on probation for a period of One year, from the date of joining. On satisfactory completion of probation, you may be confirmed by issuance of a communication to such effect. Your probation may be extended at our discretion and your services may be terminated during the probationary period with 30 days notice. Confirmation will not be a matter of right and unless intimated, in writing, confirmation may not be presumed.
- (b) You will report to the Dean, School of Engineering, Presidency University.
- (c) You will be governed by the Service Conditions, Statutes of the University, Employment and Disciplinary Rules and Regulations of the University as may be prevalent from time to time.
- (d) Your appointment and continuance in the services of the University is incumbent upon your being medically fit to carry out your responsibilities, which would be certified by a medical Practitioner nominated by us.
- (e) In the event of severance of employment on either side, for any reason whatsoever, it is mandatory for issuance of 30 days prior notice, in writing, during the period of probation. Thereafter namely after confirmation three months notice, in writing shall be required. It shall, however, be open to us to waive the notice period and/or pay an amount equivalent to one or three month's compensation as applicable and sever your employment immediately.

- (f) Either during the probationary period or upon confirmation you shall not carry on any business activities, directly or indirectly, or be engaged in any other form of business activities or be involved in any service or consultancy sector and devote your whole time and attention to the duty of the University as an employee of the University, together with other duties that may be assigned to you, connected with or incidental to the post held by you.
- (g) While joining duty, kindly handover copies of all your certificates (of education and experience) for our records, along with their originals for verification of copies.

#### (4) PLACE / TRANSFER

Your present place of work will be at Presidency University Campus. During the period of your service, you shall be liable to be posted / transferred / deputed anywhere to serve any of the University's projects or any other Presidency Group establishment in India or abroad, at our sole discretion.

#### (5) SALARY AND PERQUISITES:

- (a) You will be paid a consolidated salary of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only) per month during the probationary period. Deductions as may be applicable will be made.
- (b) During probation and after confirmation of your appointment you will be eligible for leave as per the respective leave Policy of the University. You may proceed on leave with prior permission of the Dean School of Engineering. Leave shall be availed only after specific sanction being granted by the Dean School of Engineering. Merely submitting an application for leave would not be deemed to amount to sanction of leave.
- (c) You will be eligible for medical insurance as per the policy of the University.
- (d) You will also be eligible for Provident Fund as per the policy of the University.
- (e) You shall be solely responsible for paying all taxes, director indirect, which may result from the remuneration.
