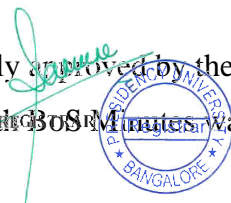





The member secretary presented the salient features of proposed program structure and CBCS Course grid including course catalogues in **Annexure EEE 12.6** which was duly approved after much deliberation with following discussion points:

- (i) Dr Pradeep Kumar Yemula suggested strengthening the role of faculty advisor need to be addressed in order to guide the students to choose the appropriate courses.
- (ii) Dr Pradeep Kumar Yemula suggested having multi-disciplinary student project groups in every semester and a project expo may be conducted once in an academic year.
- (iii) Dr Vignesh V recommended to include topics such as electromechanical energy conversion and three phase transformers in Electrical Machines (EEE2006) course and to include Laboratory component in the Discipline elective course, Computer Applications in power systems (EEE3016).
- (iv) Dr S Senthil Kumar suggested that the instructors can frame the questions instantly during lab sessions instead of pre-defining in course catalogue catering to level 2 questions.
- (v) The member secretary requested external expert from the industry Dr S Senthil Kumar to extend his support to carry out **Industry Taken to the class concept** by demonstrating the real time industrial operations in virtual mode during the laboratory sessions at least once in a semester.
- (vi) Dr Vignesh suggested providing an option for less CGPA students to choose credits/courses either from Discipline Electives or Open electives in lieu of University project.

The recommendations of the experts were considered and addressed as follows:

- (i) **Strengthening the faculty advisory system:** The University is already having effective mentoring system by the faculty advisors and the same can be further strengthened/ trained in order to guide the students for selecting the appropriate courses.



- (ii) **Multi-disciplinary student project groups in every semester:** The multi-disciplinary innovative project course is already incorporated in the proposed curriculum (CBCS) for the first and second semester students and the same may be extended in due course of time.
- (iii) The topics of Electromechanical Energy conversion and three phase transformers are included in Electrical machines (EEE 2006) course. The laboratory component is included in discipline elective course of computer applications in power systems (EEE 3016) and the revised credit structure is 3-2-4.
- (iv) **Framing of instant questions (Level 2) in laboratory:** The suggestion is well considered and the same thing will be practiced in laboratory sessions.
- (v) **Industry Taken to the class concept:** The concept was appreciated by the industrial expert and expressed his willingness to support the model.
- (vi) **Option to choose credits/courses either from Discipline Electives or Open electives in lieu of University project for less CGPA students, if interested:**

The suggestion was considered but as per the University Academic Regulations, it may not be possible to implement in this Academic year, however it will be placed before academic council for further action.

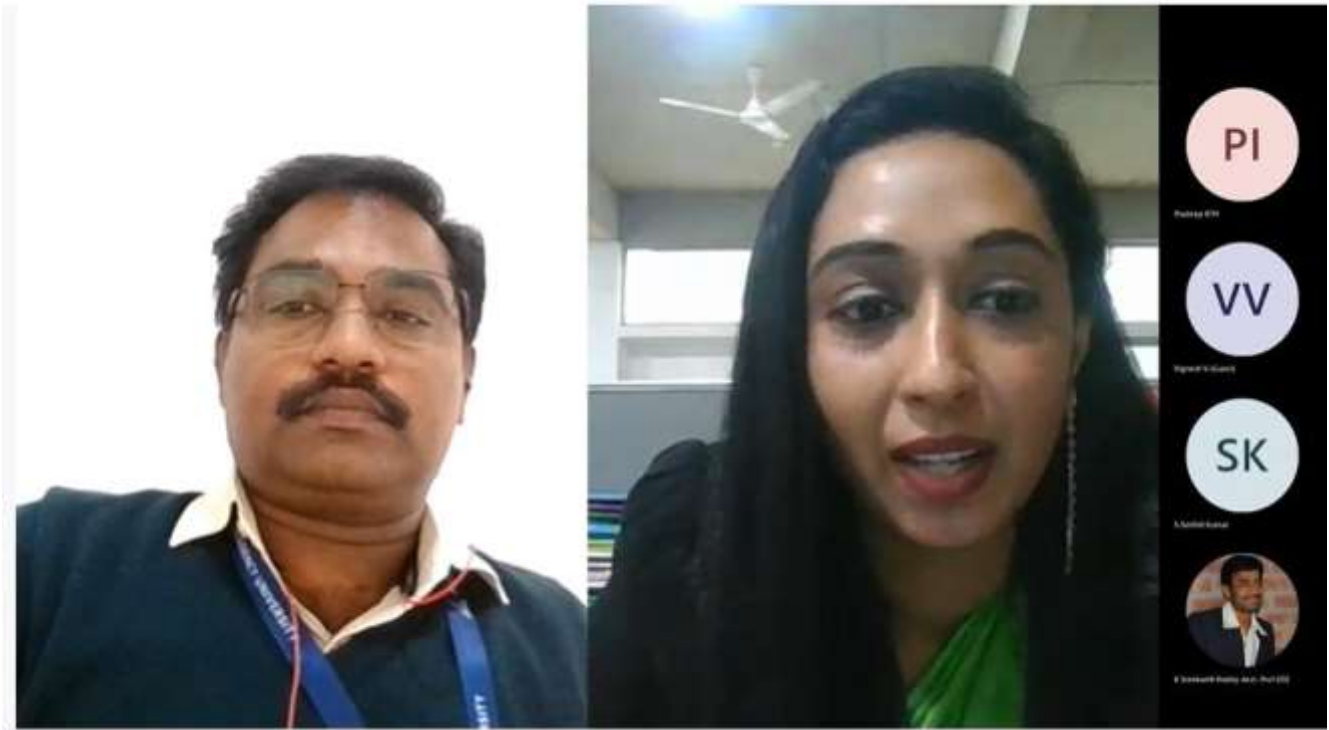


Fig. 1. The screenshot of 13th BoS meeting on MS Teams

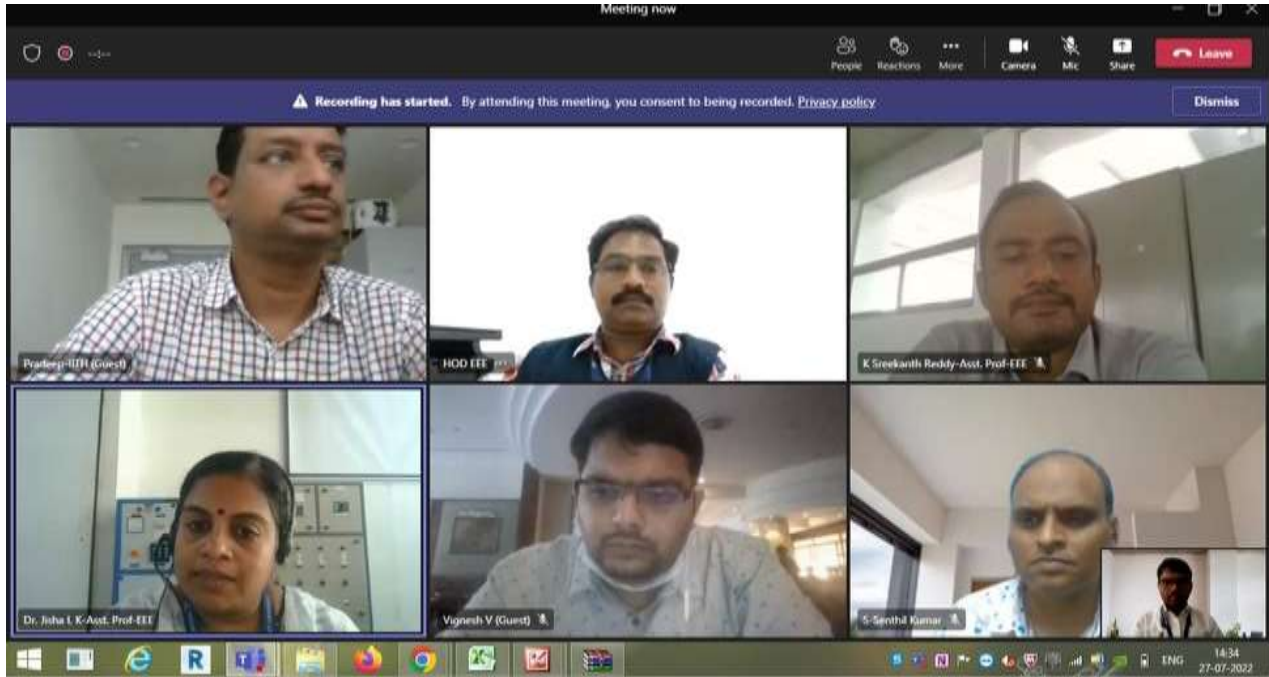


Fig. 1. The screenshot of 15th BoS meeting on MS Teams




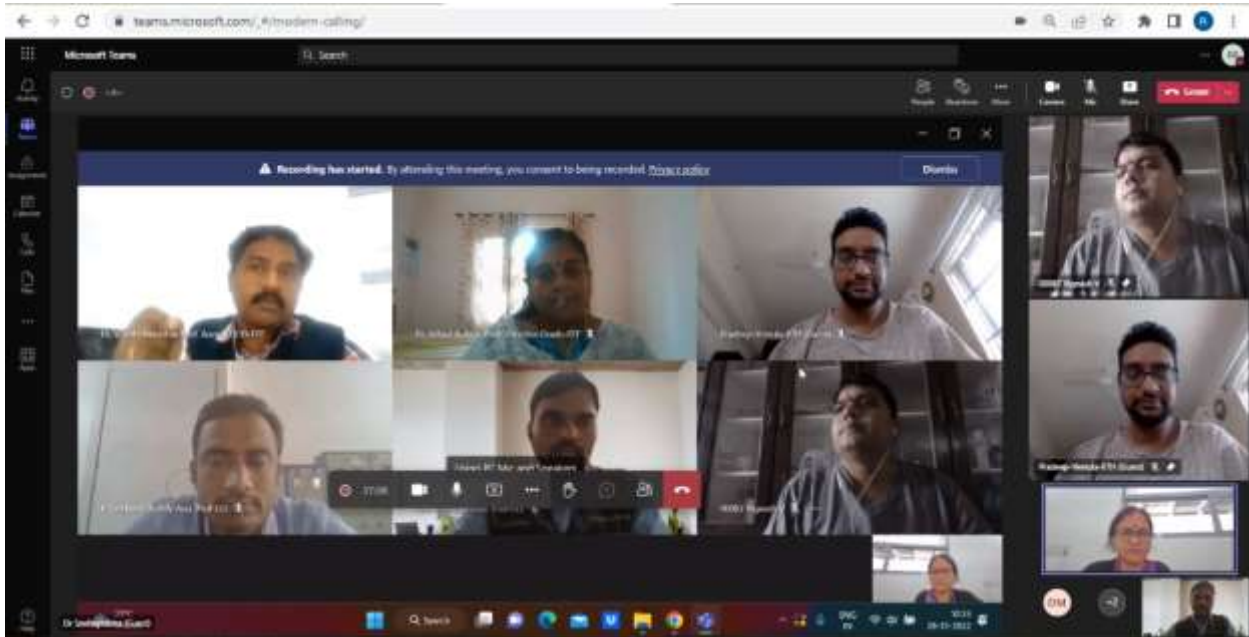




Fig. 1. The screenshot of 16th BoS meeting on MS Teams

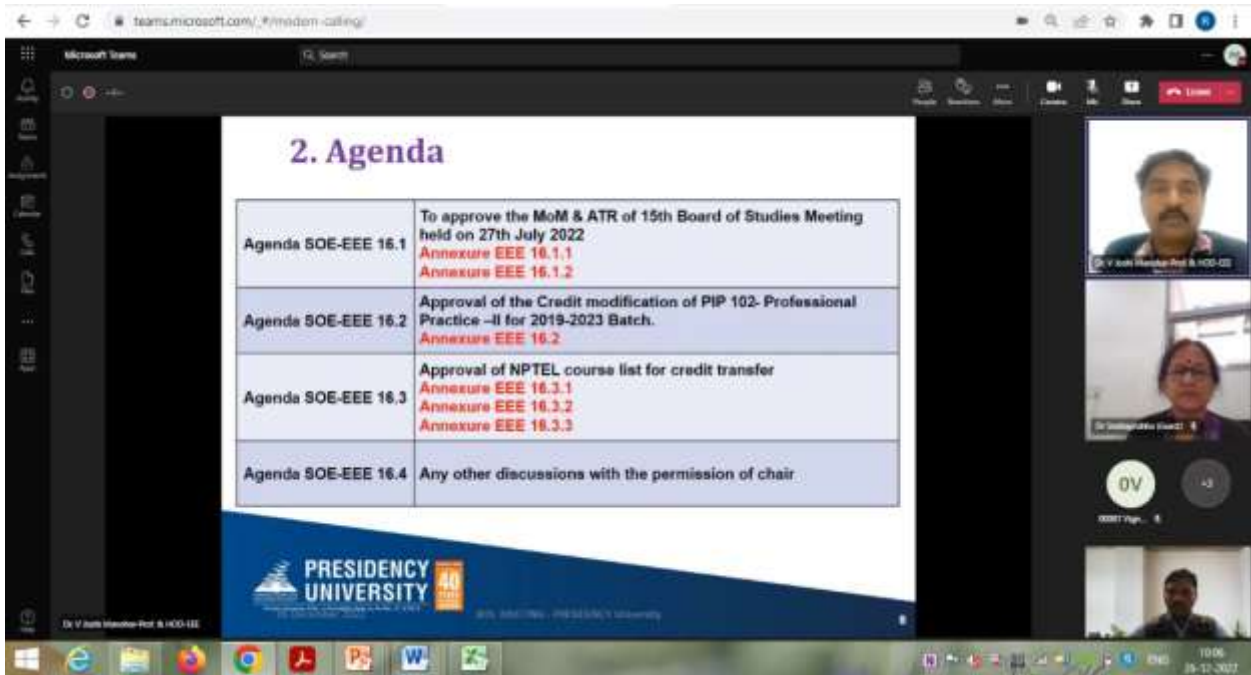


Fig. 2. The Member Secretary presenting the 16th BoS agenda points

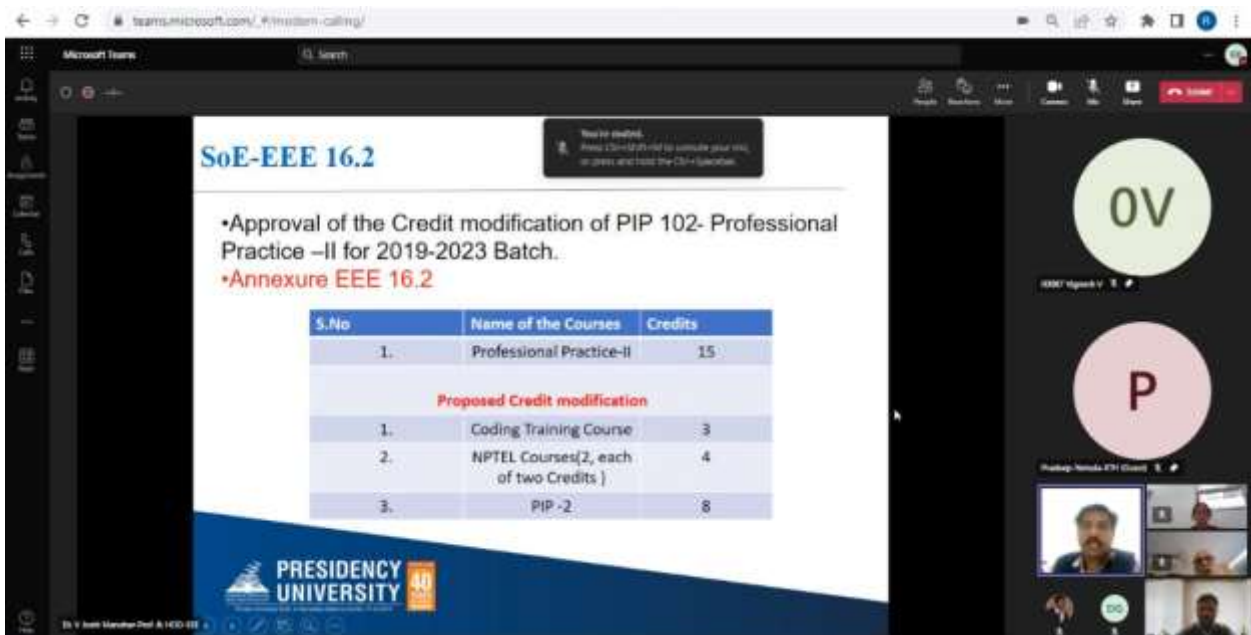


Fig. 3. The Member Secretary presenting Credit modification of PIP 102- Profession Practice-II

The member secretary/ HoD extended a warm welcome to the members, particularly to the external members and introduced all the members in the committee. The member secretary of 17th BoS meeting, delivered the opening remarks by requesting BoS members to deliberate on each agenda and to provide constructive suggestions for the effective implementation of curriculum.

The member secretary had presented the following agenda points and deliberations were recorded.

Agenda SOE-EEE 17.1: Approval of the MOM and ATR of the 16th Board of Studies meeting held on 26th Dec 2022

Resolution SoE-EEE 17.1: The Minutes of 16th BoS meeting held on 22nd February 2022 and its Action taken report (ATR) was discussed and approved by the members. **Annexure SOE-EEE 17.1.1 and Annexure SOE-EEE 17.1.2**

Agenda SoE-EEE 17.2: Deliberation and approval of the Credit structure and Curriculum Structure for 2023 admitted students for AY 2023-24

Resolution SoE-EEE 17.2: The member secretary presented the CBCS course grid, Credit structure and Curriculum for the 2023 admitted students and proposed changes were discussed and approved as listed in **Annexure- SOE-EEE 17.2**.

The external experts suggested the following points which may be considered for further approval.

- i. Tutorial component 2-1-0-3 may be included for the courses like EEE2001_v02 and EEE2007
- ii. The choice may be provided for the students to choose either CSE1002 or CSE1003 without making these two courses mandatory.
- iii. The courses like machine learning algorithms and data science may be included in the school core basket.

The recommendations of the experts were considered and addressed as follows:

- i. The courses Signals and Systems (EEE2001_v02) and Control Systems Engineering (EEE2007) are having separate laboratory courses, hence, It may not be considered for including Tutorial Component.

ii & iii The suggestions were considered but as per the University Academic Regulations, it may not be possible to implement at the Department level, however it will be placed before academic council for further discussion & action.

- ii. In order to provide better learning experience to the students the courses like PPS402 Preparedness for interview and PPS403 Developing Advanced Aptitude Skills may be scheduled one after the other (May be in the same semester not in parallel).

The above mentioned were welcomed, however in order to maintain the uniformity among School of Engineering and SoCSE, the first suggestion may not have been allowed as per the University Academic Regulations. The second suggestion was considered and it has been already implemented.

The action taken report of feedback collected is presented in **Annexure SOE-EEE 17.6.2** All the members have appreciated the efforts and the BoS members suggested to include courses related to Machine learning, Data science and laboratory related to Electric Vehicle technology maybe introduced in the curriculum.

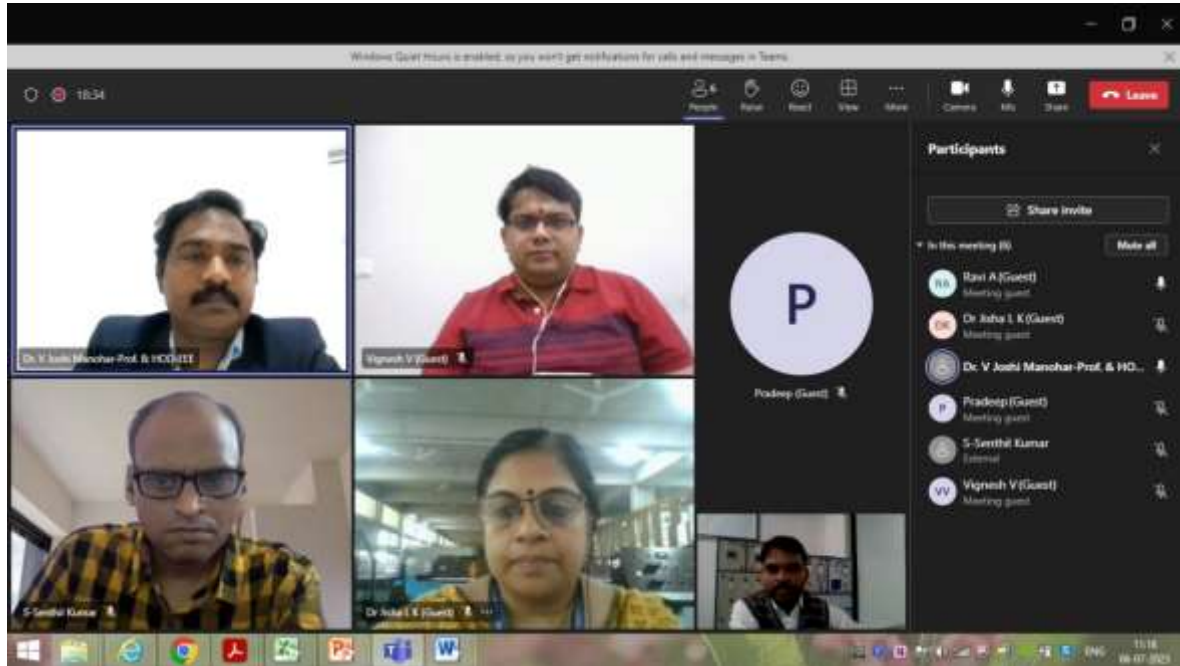


Fig. 1. The screenshot of 17th BoS meeting on MS Teams
