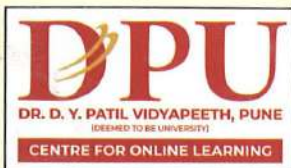

and mentoring students, has played a crucial role in the school's success.

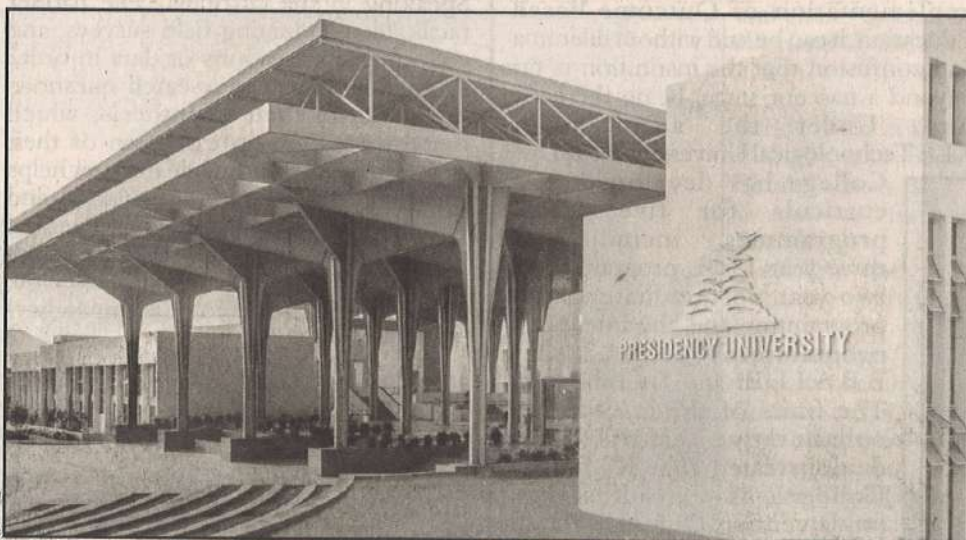

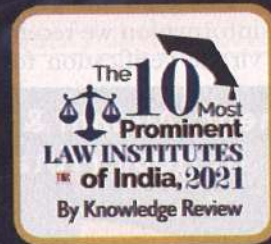
